The Sugar Board of Tanzania (SBT) has set aside funds for financing the proposed Rehabilitation of Proposed Sukari House on Plot No. 2327/28, 2326/28 and 2352/3 Sokoine/Ohio Street Ilala Dar es Salaam, and intends to apply part of the funds for payments under the contract for which this invitation for bids is issued.
- 2. Sugar Board of Tanzania has initiated a bid process and invites sealed bids for the Rehabilitation of Proposed Sukari House on Plot No. 2327/28, 2326/28 and 2352/3 Sokoine/Ohio Street Ilala Dar es Salaam from eligible contractors. The works under this contract are expected to begin at the site in November, 2016 and are expected to take a maximum of Six (6) months for completion.
- Sugar Board of Tanzania now invites sealed bids from eligible Contractors (including all
 members of a joint venture) meeting the qualification criteria who is registered with the
 Contractors Registration Board of Tanzania in CLASS SIX AND ABOVE of Building
 category.
- 4. Bidding will be conducted through the National Competitive Bidding procedures specified in the Public Procurement 2011 (Goods, Works, Non-Consultancy Service and Disposal of Public Assets by Tender) Regulations, 2013 Government Notice No. 97.

Interested Contractors may obtain further information from and inspect the Bidding Documents at the office of the Secretary of the Tender Board, Sugar Board of Tanzania 6th Floor of Sukari House room no.12 along Sokoine/Ohio Street P.O. Box 4355, Dar es Salaam, from 0900 to 1600 hours local time on Mondays to Fridays except Saturdays, Sundays and Public holidays.

- 7. All Bids must be accompanied by a Bid Security in an acceptable form (i.e. Bank Guarantee Banker's Cheque or Cash) in the amount of Tanzanian Shillings Twenty Million only (Tzs 20,000,000) and properly addressed to the Director General, Sugar Board of Tanzania, P.O. Box 4355 Dar es Salaam.
